Introduction

TOMRES Resource Amplifier is a scientific tool developed as part of Horizon2020 project TOMRES that has received funding from the European Union's Horizon 2020 research and innovation programme under grant agreement No 727929. What data do we collect?

The system collects the following data:

- Broader data on socio-economic performances at the targeted farm
- Agricultural management practices (field crops, crop production quantification, application of pesticides and fertilizers, and other type of practices like irrigation, type of production (organic or conventional) and livestock)

How do we collect your data?

You directly provide the system with most of the data necessary to function. The system collects data and process data when you:

- Use the system for assessment and analysis of field/plot/greenhouse performance related to resource use efficiency, environment and socio-economic conditions.
- Use or view our website via your browser's cookies.

How will we use your data?

The system collects your data so that it can:

- Process your order for assessment and analysis of field/plot/greenhouse performance related to resource use efficiency, environment and socio-economic conditions.

Above stated ways of data collection are strictly valid for activities related to the Horizon2020 project TOMRES, and are in use during the project life span. However, if there is a new project funded by the European Commission (e.g. structural funds, Horizon Europe), in which at least one of the partners from TOMRES will participate, your data may be used for the following:

- Validate and improve (in the future) the models' performance based on practical usage of the system.
- Analyze long-term and general practices farmers are applying when managing their tomato productions.
- Perform other scientific research in regard with food production, agriculture, environment protection and related disciplines.

The collected data are not publicly disposed, but protected by the user credentials. Each user has access to its own data.

How do we store your data?

Your data are securely stored on data servers at Jozef Stefan Institute in Ljubljana, Slovenia, with proper protection which includes firewalls and limited access to the network on which the servers are attached.

Your data will be kept on the aforementioned location with no limitation regarding the time, or until you request they to be completely deleted.

Marketing

There is no intention by any of the TOMRES partners to use your data for commercial and marketing purposes.

What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request copies of your personal data.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request us to complete the information you believe is incomplete.

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
